



This form confirms an athlete's availability to participate in the regattas below. We must have this information for the coaches to know which athletes to consider for boat selection. Please review the regatta dates carefully as permission is a commitment to the event and to the team.

All athletes must provide this signed permission slip by **Friday, January 31, 2020 with post-dated checks for the events they will be participating in.** Permission to participate may not result in an athlete actually competing in every regatta. However, failure to return this form will result in athlete ineligibility.

REGATTA DEPOSITS

Deposits must be received by the date assigned by the Regatta Chair as follows:

- **Send a deposit check for EACH regatta** that the athlete would like to attend in the deposit amount shown below (i.e.: If the rower is eligible for three regattas, send three separate checks.)
- Make each check payable to 'Tempe Junior Crew'
 - * Sign each check. Date each check with the regatta's Deposit Date (see dates on the table below).
 - * Write the rower's name and regatta on the memo line of each check.
 - * Your check will be deposited into TJC's account on the Deposit Date.
 - * If deposits are not submitted, the rower will be ineligible for that regatta.

All deposits are nonrefundable. The only exception is if a deposit is paid for and an athlete is not selected for a boat. No refunds will be made for airfare once a group reservation is made for the flight to Sacramento for Southwest Regionals. Actual costs for each Regatta may vary. You acknowledge that the deposits are an estimate that is not binding on the team and you accept responsibility for your athlete's share of any regatta cost in excess of the deposit amount.
